



**CALL FOR APPLICATIONS 2024 - 2025 FOR ADMISSION TO LEVELS I AND II  
ADVANCED PROFESSIONAL COURSES**

**DECREES**

**Art. 1 - GENERAL PROVISIONS**

This call for applications contains the provisions governing admission, for the academic year 2024-2025, to the Level I and Level II Advanced Professional Courses set out in

Annex 1 and including places reserved for public employees on the basis of the PA 110 with honours ("PA 110 e lode") Memorandum of Understanding.

The **Regulations** and **Study Plan** of each Advanced Professional Course are published on the webpage of each Advanced Professional Course available at <https://www.uniroma1.it/en/pagina/list-advanced-professional-courses>

## **Art. 2 – GENERAL ADMISSION REQUIREMENTS**

Level I Advanced Professional Courses are only open to holders of a first cycle or higher cycle degree or academic diploma or other equivalent qualification issued abroad recognised as suitable according to current regulations.

Level II Advanced Professional Courses are only open to holders of a degree completed under the old university system (prior to Ministerial Decree 509/99), a master's degree, a second-cycle academic diploma or other equivalent qualification issued abroad recognised as suitable based on current regulations.

In the case of the Faculties of Medicine, holders of the qualifications referred to in Article 1, paragraph 10 of Decree-Law No. 402 of November 12, 2001, converted into Law No. 1 of January 8, 2002, may also be admitted to first-level Advanced Professional Courses.

## **Art. 3 - ORGANISATION OF EDUCATIONAL ACTIVITIES AND ATTENDANCE**

The study plan is normally of one year's duration. The educational activities are equal to 1500 hours of total commitment, of which at least 300 hours are devoted to classroom lectures. The remaining hours may be used for other educational activities such as internships, seminars, conferences and conventions on topics related to the same subjects of the Advanced Professional Course, individual study and preparation and final exam.

The annual didactics and the number of credits (ECTS) assigned to each activity are shown in the study plans that can be consulted on the web page of the specific Advanced Professional Course (<https://www.uniroma1.it/en/pagina/list-advanced-professional-courses>).

Attendance at the course's educational activities is compulsory and must be attested. As a rule, non-attendance of more than 25% of the total number of hours of lectures will result in the student's inability to be admitted to the final exam and to obtain the degree.

In the event of non-attendance, poor results, failure to make regular payments or otherwise reprehensible behaviour, the Advanced Professional Course Scientific Educational Board may decide to suspend or exclude the participant. In such cases, the tuition fees paid will not be refunded.

## **Art. 4 - NUMBER OF PLACES AVAILABLE**

All the Advanced Professional Courses are restricted access courses. The maximum number and minimum number of students admitted, necessary for the activation of each Advanced Professional Course, are indicated in the course **Regulations** which can be consulted on the web page of each Advanced Professional Course (<https://www.uniroma1.it/en/pagina/list-advanced-professional-courses>).

The available places reserved for public employees on the basis of the Project PA 110 with Honours Memorandum of Understanding are indicated in Annex 1. When 'supernumerary' is indicated, it is understood that there is no maximum limit.

## **Art. 5 - REGISTRATION IN THE INFOSTUD INFORMATION SYSTEM AND UPLOADING OF UNIVERSITY QUALIFICATIONS**

To take part in the admission procedure, candidates must, **under penalty of exclusion**:

- obtain a Student ID number by registering on Infostud 2.0 at the page [Infostud 2.0 | Sapienza University of Rome \(uniroma1.it\)](https://www.uniroma1.it/infostud20)
- enter on their Infostud profile their university degree, which is relevant for admission to the Advanced Professional Course, in accordance with the following instructions: go to the page [Students | Sapienza University of Rome \(uniroma1.it\)](https://www.uniroma1.it/students), go to Infostud 2.0> Profile> University Degrees
- enter their bank account details on their Infostud profile, useful for the purposes of any refunds: go to the page [Students | Sapienza University of Rome \(uniroma1.it\)](https://www.uniroma1.it/students), log in to Infostud 2.0> Profile> Account. Please note that the bank account indicated must necessarily be in the student's name.

SPID or CIE credentials are required to access Infostud, in compliance with the "simplification and digital innovation" Decree Law.

Only candidates who are non-Italian citizens without SPID will be able to log in with their Infostud registration credentials (Student ID number and password).

Those who have already registered in Infostud in the past do not have to perform the procedure again but log directly into the system.

## **Art. 6 - PAYMENT OF THE ADMISSION TEST/QUALIFICATIONS ASSESSMENT FEE**

The candidate is required, **under penalty of exclusion**, to pay the contribution for the admission test/assessment of qualifications amounting to € 51.00 (€ 35.00 contribution + € 16.00 stamp duty paid virtually), to be paid by **January 31, 2025** with the exception of Advanced Professional Course code 29034 in "Big Data. Statistical methods for the knowledge society" for which payment must be made **by January 15, 2025**.

Payment is also due in the case of applications for the INPS executive, INPS Junior and PA 110 with honours scholarships, and must be made by the deadline specified in this call for applications.

Payment is also due in the case of the assessment of qualifications alone.

To make the payment, follow the procedure below:

- select in order: Advanced Professional Courses > Course Admission > Enter the course identification code (to be found in Annex 1 of this call for applications) > Continue

**Payment of the admission test fee must necessarily be made in the online mode with direct payment.**

**Payment methods other than those provided for and complaints due to failure to pay by the above-mentioned deadline will not be accepted. Applicants are therefore invited to complete the procedure sufficiently in advance of the deadline to enable the offices to provide due assistance if necessary.**

The admission test fee/qualifications assessment is not refundable for any reason whatsoever except for the refund of the sole amount of € 35.00, excluding stamp duty,

if the Advanced Professional Course is not activated. Any reimbursement will be made to the bank account whose IBAN has been registered in the Infostud profile (see art. 5).

#### **Art. 7 – APPLICATION SUBMISSION AND ADMISSION DOCUMENTS**

**By January 31, 2025**, (January 15, 2025 for Advanced Professional Course code 29034 in "Big Data. Statistical methods for the knowledge society") **under penalty of exclusion**, the candidate shall send the following documents to the email address published on the web page of each individual Advanced Professional Course <https://www.uniroma1.it/en/pagina/list-advanced-professional-courses>:

- Application for admission in Annex 2, duly completed and signed;
- Photocopy of a valid identity document (ID card - car licence - passport);
- CV
- Copy of the receipt for payment of the admission test/qualifications assessment contribution of € 51.00, paid in accordance with the procedures indicated in Art. 6 of this call for applications

To this documentation, which is compulsory for all applicants, the following must also be added if you belong to one or more of the following four categories:

1) **For candidates with an international qualification**, one of the following documents must be submitted in addition to the documents mentioned above:

- ✓ *declaration of Value* issued by the Italian Consular Authority of the country in which the study took place (accompanied by a transcript of records + copy of the final diploma)

*or*

- ✓ *CIMEA Statement of Comparability accompanied by CIMEA Statement of Verification* (by accessing the CIMEA platform: <https://www.cimea.it/pagina-attestatati-di-comparabilita-e-verifica-dei-titoli>)

*or*

- ✓ *Diploma Supplement* (if it is a European qualification) issued by the university of origin and legalised at the Italian Embassy in the country of study

*or*

- ✓ *authorisation decree* of the Italian Ministry of Health for the practice of the profession.

Those who submit incomplete documentation shall be admitted conditionally and may not complete enrolment in the Advanced Professional Course.

Any missing documentation may be supplemented no later than the deadline for the first instalment referred to in Article 10 below.

Non-EU citizens and citizens resident abroad must comply with the interministerial provisions contained in the circular "Procedures for the entry, stay and enrolment of foreign/international students in higher education courses in Italy academic year 2024-2025, available at the link: <https://www.studiare-in-italia.it/studentistranieri/>.

For those who need to obtain a study visa, it is necessary to submit a pre-application online at <https://www.universitaly.it/> and send notification of submission to [settoremaster@uniroma1.it](mailto:settoremaster@uniroma1.it)

- 2) **For candidates with a recognised disability in accordance with Article 3(1) and (3) of Law no. 104 of 1992 and/or with a disability of 66% or more**, it is necessary to submit, in addition to what has already been described:

- a copy of the certificate of disability or law 104/92 issued in accordance with the law, under penalty of exclusion from the facilities provided; the same certificate must also be forwarded to the Unit for Students with Disabilities and Specific Learning Difficulties at the following email address:

- 3) **For candidates with simultaneous enrolment, for the academic year 2024-2025, in another course at Sapienza University of Rome** who are interested in enrolling in an Advanced Professional Course in the same academic year, and who have verified that it is not incompatible with the course attended, it is necessary to submit in addition to the above:

- simultaneous enrolment application form in Annex 3 of this Call for applications.

Students are reminded that pursuant to Article 15 of the Sapienza University of Rome PhD Regulations, attendance of PhD courses is incompatible with simultaneous enrolment in Level I and II Advanced Professional Courses.

Students with simultaneous enrolment will have their Student ID number duplicated, in order to manage the two academic careers separately.

Please note that the simultaneous enrolment form is not due in the case of simultaneous enrolment on courses at other universities.

- 4) **For candidates who are employed in the public administration and who wish to avail themselves of the facilities provided for in the PA 110 with honours Memorandum of Understanding**, it is necessary to submit, in addition to what has already been described:

- replacement statement of certification as set out in Annex 4 to this call for applications

It is possible to join the facilities provided by the PA 110 with Honours Memorandum of Understanding exclusively for the Advanced Professional Courses joining the project for the academic year 2024-25. The Advanced Professional Courses concerned are indicated in Annex 1 to this Call for Applications, together with the available places.

Applications with incomplete documentation, submitted using methods other than those provided for in this call for applications, sent to email addresses other than those published on the web page of each Advanced Professional Course (<https://www.uniroma1.it/it/pagina/elenco-dei-master>) or submitted after the deadline will not be accepted.

#### **Art. 8 - SELECTION PROCEDURE**

In order to be admitted to the Advanced Professional Course, the candidate must possess one of the university qualifications (referred to in Article 2 of this call for applications) indicated in the admission requirements described in the **Study Plan** of each Advanced Professional Course (<https://www.uniroma1.it/en/pagina/list-advanced-professional-courses>).

If an admission test is required, it will take place, for each Advanced Professional

Course, following the procedures described on the webpage of each Advanced Professional Course (<https://www.uniroma1.it/en/pagina/list-advanced-professional-courses>).

#### **Art. 9 - PUBLICATION OF THE ADMISSION LIST / RANKING LIST**

At the end of the assessment of qualifications and/or the possible admission test, a list of candidates admitted will be published on the web page of each Advanced Professional Course. The publication of the list of candidates admitted shall constitute notification for all purposes. If the number of candidates exceeds the number of places available, the candidates will be placed in a special ranking list and only those who have been placed among the successful candidates in the above-mentioned list will be admitted to the Advanced Professional Course; successful candidates will be admitted to the Advanced Professional Course only if one or more of the successful candidates withdraws.

#### **Art. 10 - PAYMENT OF THE ADVANCED PROFESSIONAL COURSE ENROLMENT FEE**

The candidate admitted to the Advanced Professional Course must make the payment of the first or one-off instalment of the enrolment fee, **no later than February 28, 2025**. The amount to be paid for enrolment, together with the amount of the reduced fee for Advanced Professional Courses adhering to the PA 110 with honours Memorandum of Understanding, are published on the web page of each Advanced Professional Course (<https://www.uniroma1.it/en/pagina/list-advanced-professional-courses>).

The breakdown of payment in two instalments or in a one-off instalment is indicated in the course Regulations published on the web page of each Advanced Professional Course.

To make the payment, follow the procedure below:

- access Infostud from <https://www.uniroma1.it/en/pagina-strutturale/graduates>;
- select in order: Advanced Professional Courses > First year > Enter the course identification code (to be found in Annex 1 of this call for applications) > Continue.

If the list of admitted students has been published, pursuant to Article 10, paragraph 1 of the "Regulations", students admitted to the Advanced Professional Course who fail to pay the first instalment by **February 28, 2025**, will have to pay a late payment surcharge of €65.00. After 60 days from the deadline set out in the call for applications, the surcharge will be due at twice the standard rate.

In the event that a ranking list has been published in accordance with Article 10, paragraph 2 of the "Regulations" and there are eligible students who could take over, a student admitted to enrolment who does not pay the first instalment by **February 28, 2025**, will be considered to have withdrawn.

Any enrolment of such candidates may only take place after the offices have gone through the whole list of candidates in the ranking.

The deadline for paying the second instalment is **May 30, 2025**.

To make the payment, follow the procedure described for the payment of the first instalment. Failure to comply with the payment deadline for the second instalment shall result in a late payment surcharge of € 65.00. If the payment of the second instalment is made after 60 days from the deadline specified in the call for applications, the



surcharge will be due at twice the standard rate.

**Pursuant to paragraph 9 of Article 12 of the "Regulations", a student who is not in good standing with the payment of fees and contributions may not, for the entire period covered by the aforementioned payment default, take exams, attend courses, internships or perform any career-related action, or obtain certificates.**

After the deadlines, the student is not allowed to prepare the respective payment forms online from the Infostud 2.0 system, therefore it will be necessary for the Advanced Professional Course's Director to authorise late payment by making a request to [settoremaster@uniroma1.it](mailto:settoremaster@uniroma1.it).

#### **Art. 10a - REDUCTION OF ENROLMENT FEE FOR PUBLIC EMPLOYEES IN THE "PA 110 WITH HONOURS" PROJECT**

Public employees who meet the requirements of the "PA 110 with honours" Project pay the reduced enrolment fee as indicated on the web page of each Advanced Professional Course participating in the Project (see Annex 1).

During the same academic year, it is possible to take advantage of the facilities provided by the PA 110 with honours Memorandum of Understanding for enrolment in only one programme, either at Sapienza University of Rome or at other Universities.

The cumulative payment of the enrolment fee for public employees by institutions is not allowed.

Within 60 days of obtaining the qualification, in the sole case in which the Department of the Public Function has definitively approved the inclusion of the specific Advanced Professional Course in the educational offer of the "PA 110 with honours" Project, this University will reimburse 50% of the enrolment fee paid up to a maximum of € 2,500.00.

INPS Executive scholarships are incompatible with the benefits provided by the PA 110 with honours project, therefore candidates who have indicated, during the application phase, their intention to participate in the PA 110 with honours project and who subsequently become beneficiaries of an INPS Executive scholarship, are required to immediately inform the University by sending an email to [settoremaster@uniroma1.it](mailto:settoremaster@uniroma1.it).

In the event that the student has already paid the first instalment or one-off instalment (reduced in accordance with the PA 110 with honours project), the University will reimburse the amount paid (with the exception of the admission test fee) at the request of the interested party.

#### **Art. 10b - REDUCTION OF THE ENROLMENT FEE FOR STUDENTS WITH DISABILITIES**

Students with a recognised disability within the meaning of Article 3, paragraphs 1 and 3 of Law no. 104 of February 5, 1992, and/or with a disability equal to or greater than 66% are exempt from paying 50 % of the tuition fee, without prejudice to any other exemption established by the regulations (Article 30, paragraph 9 of the "Regulations").

**In order to generate the reduced payment amount, it is necessary to select the "Disabled student" exemption in Infostud by self-certification, also indicating the type of disability or impairment.**

Students with disabilities referred to in the first paragraph of the present article must send an email to the Unit for Students with Disabilities and Specific Learning Difficulties mailto: [servizio.disabilita@uniroma1.it](mailto:servizio.disabilita@uniroma1.it) and for information to

settoremaster@uniroma1.it, specifying the name of the Advanced Professional Course or the relevant code, a copy of the disability certificate - indicating the percentage of disability, or for cases provided for by law, only the type of disability - or the certificate of disability pursuant to Article 3, paragraphs 1 and 3, of Law no. 104 of February 5, 1992.

The financial aid referred to in this article shall be effective from the moment the application is submitted and may not be retroactive except for the ongoing academic year, taking into account the date of submission of the application for recognition of disability.

As provided for in art. 6, par. 4 of the Memorandum of Understanding between the Public Administration and Sapienza University of Rome, the exemption from the payment of 50% of the enrolment fee reserved for students with disabilities and the reimbursement of 50% of the enrolment fee provided for in the PA 110 with honours Memorandum of Understanding for public employees upon graduation are not cumulative, the reimbursement referred to in Article 10a of this call for applications shall not apply.

#### **Art. 11 - CONDITIONAL ADMISSION FOR GRADUATING CANDIDATES**

Graduating candidates, without a degree for admission to the Advanced Professional Course, who wish to participate in this call for applications must, in addition to the Infostud registration provided for in Art. 5 above, declare their status as a graduating student by clicking on Profile - University Qualifications and selecting the flag *Graduating student ("Laureando")*. They will then have to follow the procedures for payment of the admission test fee set out in Article 6. They will be conditionally admitted to the Advanced Professional Course and, in the event of a ranking, placed at the very bottom of it.

#### **The degree must be obtained no later than March 31, 2025.**

In order to be duly enrolled in the Advanced Professional Course, candidates must inform the Director of the Advanced Professional Course and [settoremaster@uniroma1.it](mailto:settoremaster@uniroma1.it) by email, within 10 days from the date of acquisition of the qualification and under penalty of forfeiture of enrolment, that the qualification has been obtained; they will receive instructions by email on how to pay the enrolment fee due, without any surcharge for late payment, to be paid by the deadline indicated on the enrolment form.

Candidates who have not obtained their degree from Sapienza University of Rome are also required to update their academic career in their Infostud profile, entering in the section "Profile - University degrees" the date the degree was obtained and the relative grade, removing the flag in the "graduating student" box.

#### **Art. 12 - FUNDING AND/OR SCHOLARSHIPS**

Funding may be made available to enrolled students by external bodies that have an agreement with the Advanced Professional Course to cover part or all of the enrolment fee, which is allocated according to criteria and procedures defined and made public by the funding body. Any scholarships, partial or total exemptions from enrolment fees already known at the time of publication of this call for applications are indicated in the Study Plan of each Advanced Professional Course available at <https://www.uniroma1.it/en/pagina/list-advanced-professional-courses>

For candidates who are public employees taking part in the PA 110 with honours project, no external bodies can pay part or all of the enrolment fee.



### **Art. 13 - AUDITOR CANDIDATES**

Where provided for in the course's **Regulations**, the Advanced Professional Course may be attended as supernumerary auditors by subjects who do not meet the admission requirements.

The enrolment fee for auditors is 30% of the Advanced Professional Course enrolment fee.

Interested parties must notify the Advanced Professional Course Director and [settoremaster@uniroma1.it](mailto:settoremaster@uniroma1.it) of their willingness to participate by e-mail. The Director will notify the Advanced Professional Course Director and [settoremaster@uniroma1.it](mailto:settoremaster@uniroma1.it) of the acceptance of the request, as well as the terms and conditions of enrolment and payment of the participation fee.

Auditor students cannot be counted in the minimum number of students enrolled in the Advanced Professional Course.

Under no circumstances may auditors participate in workshops and attend internships, they do not sit the final exam and do not acquire ECTS.

At the end of the Advanced Professional Course, the auditor who has met the minimum attendance requirement may receive a certificate of attendance from the Advanced Professional Course's Educational Affairs Office.

### **Art. 14 - SINGLE COURSES**

Those who meet the same admission requirements for admission to the Advanced Professional Course may enrol in single courses of the Advanced Professional Course, where envisaged by the **Regulations** and up to a maximum of 20 ECTS.

Those enrolled in single courses may take the relative exams and obtain certification of the ECTS acquired by the Advanced Professional Course Director.

If the Advanced Professional Course is not activated, the related single courses cannot be activated unless they are converted into Advanced Training Courses.

Credits acquired in single courses within Advanced Professional Courses may be evaluated for the purposes of enrolment in other university courses.

The minimum enrolment fee for each course is calculated on the basis of the number of ECTS to be acquired, as indicated in Article 17, paragraph 5 of the "Regulations".

In order to be authorised to enrol in a single course and to know how to make the payment due, it is necessary to make a request by email to the Director of the Advanced Professional Course and to [settoremaster@uniroma1.it](mailto:settoremaster@uniroma1.it)

### **Art. 15 - WITHDRAWAL**

Admitted participants who intend to withdraw from the Advanced Professional Course must give written notice of their intention to do so to the e-mail address of the Advanced Professional Course Director available on the institutional web page of each course (<https://www.uniroma1.it/en/pagina/list-advanced-professional-courses>) and to [settoremaster@uniroma1.it](mailto:settoremaster@uniroma1.it). Any enrolment fees already paid are non-refundable (Art. 16 paragraph 9 of the "Regulations").

### **Art. 16 - PROCEDURES FOR CARRYING OUT THE FINAL EXAM AND OBTAINING THE QUALIFICATION**

The procedures for the final exam are indicated in the Study Plan of each Advanced Professional Course available at <https://www.uniroma1.it/en/pagina/list-advanced-professional-courses>.

The final exam is conducted in person before an examining committee, which assigns a score out of one hundred and ten points. The committee may, by unanimous decision,

award the candidate the maximum score with honours. The minimum passing score for the final exam is 66/110 (sixty-six out of one hundred and ten).

Before taking the final exam, students are required to pay a fee of €75.00 and complete the AlmaLaurea survey following the instructions provided at the following link: <https://www.uniroma1.it/en/pagina/master-final-exam>

Only students who are up to date with the payments of both instalments and/or the single instalment, as well as the final exam fee, may be admitted to the final exam. Additionally, before taking the final exam, students must complete the AlmaLaurea survey according to the instructions provided at the following link:

#### **Art.18 - REFERENCE REGULATIONS**
